2	Minutes of last meeting and matters arising	Previous minutes agreed. As we were pressed for time today due to needing to be at Home Park for 12:00, all items were discussed but very briefly.	TC
3	Constitution of the Board	AS raised the question of whether himself and TC should be made full voting Board members as it was felt that their current duties went beyond the realms of 'support' roles to the Trust. BF agreed and put it to vote. All were in favour of TC and AS becoming full co-opted Board members. TC to report back in next meeting whether this was in the Constitution of the Trust and would check with Supporters Direct, as it is unusual	AS

4	Financial Report	AS presented the following: Income: £479.75 Expenditure: £1535.50 Balance at Bank: £8286.50 There is more money to be transferred over from the PayPal account into the main bank account however AS does not have access to this yet. TC to liaise with Bob Wright about getting the password/username for it and get the money transferred across.	AS
5	Secretary's correspondence	TC raised concern that membership tasks were falling seriously behind. He praised the former Membership Secretary – Bob Wright – who is still helping out with a lot of the online jobs. The main problem at the moment is putting packs together and getting them out. TC had also asked Bob Wright how many hours he would have spent on average in a week performing membership duties. The answer was that it was not unusual sometimes to spend 15 hrs per week. TC explained that as he normally works 50+ per week at his job, this is not something that he can commit to on top of Secretarial duties and that finding a new Membership Secretary was now of utmost importance. The Board realised this and that steps would be taken to find one from within the membership.	TC

7	Feedback on Pedal for Pounds 20 th – 23 rd April	BF offered praise to ES and Mark for representing the AFT in their completion of the P4P's bike ride. As ES was not present we were unable to discover how much they had raised in their efforts. Will be discussed in next meeting.	ES
8	Eviction of Argyle fans in hospitality at Exeter City	BF explained that the issue has now all but been resolved and that the complainant was very thankful to the AFT for getting involved in what was a very traumatic experience for them.	BF
9	Hartlepool sponsored game	All moneys have now been collected and we now have confirmed our full list of attendees	AS, BF
10	Player of the year award	All votes had previously been counted and verified, and Carl McHugh has been declared the AFT's supporters Player of the Year. TC presented the trophy to BF with Carl's name inscribed.	All
11	The Morecambe fiasco	The reply from the Football League has more or less said that nothing can be done about this and that Argyle's game was initially on the Saturday but that Argyle had requested the Friday instead.	All
